

REDD'S: Share Your Joy Terms & Conditions

1 August 2018 and ends on 31 August 2018

1. This promotional competition ("Competition") is run by The South African Breweries (Proprietary) Limited ("Promoter") and is open to all persons of 18 years or older who reside in South Africa and have valid bank accounts, except the employees and their immediate families of Promoter, Promoter's advertising and promotion agencies, associated companies, and outlet owners and staff.
2. Participation by all participants in the Redd's Share Your Joy Campaign is through the USSD (*120*603*Unique Code#) strand on pack, USSD rates 20c/20sec. Participation constitutes acceptance of these competition rules.
3. These rules may be amended by notification at any time during the Competition, and will be interpreted by Promoter only.
4. The Competition begins 1 August 2018 and ends on 7 September 2018 ("Competition Period").
5. During the competition period participants will stand a chance to win their share of R3.1million in airtime or cash prizes towards Rent, Fuel and Groceries for a year.
6. Entry and Prize redemption:
 - 6.1 Participants must buy 1x Redd's 660ml from participating outlets during the Competition Period and enter the competition through the USSD (*120*603*Unique Code#) strand on the pack.
 - 6.2 All valid entries will be entered into the draw for the Share Your Joy grand prize and stand a chance to win their share of airtime. Participants will stand a chance to win cash for rent if selected, the Participant will then be eligible to win that prize and their 2 nominated friends would win the other prizes (cash for groceries and transport).
 - 6.3 Random draws will be done on each business day for the grand prizes. Winners are to be selected from the entries from midnight of the day prior. Participants with valid entries will be entered into the draws for every day until the end of the Competition Period.
 - 6.4 Participants are only eligible to win the grand prize once, either from being the drawn winner or being nominated. If a Participant wins by being the drawn winner, then they cannot be nominated and vice versa.
 - 6.5 A drawn winner will be contacted on their winning cell number over a period of a day and no more than 3 attempts will be made to this number before moving to a backup winner. If a drawn winner doesn't answer their phone on the winning number or their phone is out of signal or off, and such winner shall have no claim against the Promoter. The Promoter will select another winner at its sole and absolute discretion.
 - 6.6 A drawn winner must provide their ID number, name and surname for verification, and proof of banking details in order for payments to be made after verification.
 - 6.7 The winner will have to nominate 2 friends who are over the age of 18 years, resident in South Africa and have valid bank accounts to claim the other 2 grand prizes after successful verification.
 - 6.8 Cash prizes will be towards the following:
 - Rent for year: R48 000.00 (R4000.00 per month paid in a lump sum)
 - Transport for a year: R24 000.00 (R2000.00 per month paid in a lump sum)
 - Groceries for a year: R24 000.00 (R2000.00 per month paid in a lump sum)
7. The winner must choose two friends or family to share the other two prizes with.
8. The prizes cannot be transferred or exchanged for cash, should airtime be won or an alternate prize should cash be won.
